

Chapter I. General

Transilvania Architecture Biennale (BATRA) brings together, once every two years, the best works of architecture, design and urban interventions made by fellow architects from the five partner branches: OAR Transilvania, OAR Bihor, OAR Satu-Mare, OAR Nord- West, OAR Alba.

The event around which Transilvania Architecture Biennale takes place is the BATRA 2023 Awards exhibition-competition, which presents the most important projects and interventions carried out in the field of architecture in the last two years.

The purpose of the exhibition-competition is to reflect as correctly as possible the activity of the members of the participating branches, to promote the most successful examples of professional practice and to form an attitude towards recent architecture. Nominations and prizes are awarded by a jury made up of established architects from the country and abroad.

Around the 2023 BATRA Awards exhibition-competition, a series of events are taking shape, which aim to attract the widest possible audience to this dialogue with and about architecture. Architects, urban planners, partners and collaborators together with representatives of professional communities from fields involved in our activity, debate, exhibit and present contemporary ideas and solutions. Also, a large part of the events is dedicated to the general public, the local communities of the five regions and the direct or indirect beneficiaries of the architectural works.

Transilvania Architecture Biennale is an event part of a series within the OAR program of financing branches for events, based on its own regulations and autonomy in organization.



Chapter II. BATRA 2023 theme

(imp) ACT

Our attempts to understand the impact of architecture led us to question its nature. The conclusions are, of course, provisional, in close connection with the ephemeral nature of the architectural discourse that is characteristic foe this dynamic era, and lies between surprise and shock, considering the wide range of typologies and interventions in urban and rural environments, but also the impact that they have on the built environment, nature, communities and each individual.

An impact analysis should start by questioning the term, which has become standard. "Impact" can be a bivalent metaphor. Although so often used, the term is perhaps too "Newtonian" or too visual. It brings to mind a collision whose repercussions, in general, are milder. Terms like "effect", "influence" or "inflection" can much better define the result of an architectural or urban intervention.

The "impact" of architecture cannot be measured in the same way that we can measure the impact of a car hitting a wall. There is no equation, so every analysis is loaded with subjectivity. The "black box", a false attempt to be "scientific", does no one any good.

This is why we should perhaps start by asking why we want to make an impact, rather than how it can be made. For example, the "broader impact" was primarily economic in nature. Everyone wants to have more money, right? But what about those situations where, due to economic growth, the environmental costs have been immeasurable?

Including non-disciplinary standards for success is a strategy of contemporary research. Can it be a solution for architecture as well? Involving those we hope our interventions will increase the chances of having a larger role and improve our work.

Of course, some will ask not how to have an impact or what impact means, but whether architecture should have an impact. Some will argue for self-sufficiency, or might argue that its effects play out over very long-time horizons and operate deep underground, in the roots of culture.

We believe that architecture has the power to change the world. The hard part is realizing how we can do this, and especially how we can change it for the better.

The 2023 BATRA Awards have the following sections:

01.

The architecture of the individual home

The section includes individual homes that are distinguished by the quality of the living spaces and the relationships with the space in which they are made. Sustainable, innovative solutions will also be appreciated, as well as the presentation in context. The section includes all individual housing projects, regardless of scale, completed in the last 2 years.

Participating projects must be carried out by architects who are members of the partner OAR Branches: OAR Transilvania, OAR Bihor, OAR Satu-Mare, OAR Nord-Vest, OAR Alba, including those from Diaspora. Architects who are members of any OAR Territorial Branch can also participate, provided that the work entered in the competition is located in one of the following counties: Cluj, Bistriţa-Năsăud, Sălaj, Alba, Bihor, Maramures and Satu-Mare.

02.

The architecture of collective housing

The section encompasses collective housing that promotes innovative community spaces, compositional coherence and professional ethics. The dialogue with the environment, the dynamics of the space, the economic efficiency, but also a sense of belonging to the place will be appreciated. The section includes all collective housing projects completed in the last 2 years.



03.

Architecture of administrative, service and production facilities

This section promotes community-specific endowments, namely: administrative, business administration, financial -banking, commercial, service and production functions, transport infrastructure and special purpose units, pursuing those interventions that significantly contribute to the quality of the built space. The section includes both new building projects and projects for the conversion, extension and rehabilitation of existing buildings, completed in the last 2 years.

Participating projects must be carried out by architects who are members of the partner OAR Branches: OAR Transilvania, OAR Bihor, OAR Satu-Mare, OAR Nord-Vest, OAR Alba, including those from Diaspora. Architects who are members of any OAR Territorial Branch can also participate, provided that the work entered in the competition is located in one of the following counties: Cluj, Bistriţa-Năsăud, Sălaj, Alba, Bihor, Maramureş and Satu-Mare.

Note: considering that mixed buildings can include functions that can be found in sections 3 and 4, the author will decide the classification according to the weight or preponderance of one of them in the proposed project

04.

The architecture of socio-cultural endowments

In this section there are buildings corresponding to programs of education and research, culture and worship, health and social assistance, sports and tourism functions, pursuing those interventions that bring added value to the built space and contribute significantly to the quality of life. The section includes both new building projects and projects for the conversion, extension and rehabilitation of existing buildings, completed in the last 2 years.

Participating projects must be carried out by architects who are members of the partner OAR Branches: OAR Transilvania, OAR Bihor, OAR Satu-Mare, OAR Nord-Vest, OAR Alba, including those from Diaspora. Architects who are members of any OAR Territorial Branch can also participate, provided that the work entered in the competition is located in one of the following counties: Cluj, Bistriţa-Năsăud, Sălaj, Alba, Bihor, Maramureş and Satu-Mare.

Note: considering that mixed buildings can include functions that can be found in sections 3 and 4, the author will decide the classification according to the weight or preponderance of one of them in the proposed project



05.

The architecture of cultural heritage

Lately, increasing importance has been given to the recovery of the existing heritage, both the one identified as national and local importance, but also the one with a modest value, charged with a contextual or sentimental value. The economic value, the sustainability of the investment and the impact within the community cannot be neglected. The section includes restoration, conservation, rehabilitation, conversion and extension projects of the existing built heritage, completed in the last 2 years.

Participating projects must be carried out by architects who are members of the partner OAR Branches: OAR Transilvania, OAR Bihor, OAR Satu-Mare, OAR Nord-Vest, OAR Alba, including those from Diaspora. Architects who are members of any OAR Territorial Branch can also participate, provided that the work entered in the competition is located in one of the following counties: Cluj, Bistriţa-Năsăud, Sălaj, Alba, Bihor, Maramureş and Satu-Mare.

06.

The architecture of the rural space

The section aims to bring to the attention of the general public and the specialized public the architectural achievements of the rural environment, thus promoting works that can become landmarks, in a world that seems doomed to lose its identity. The local specificity and the way of intervention through local techniques, crafts and materials will be highlighted. For this category, projects that house a wide range of functions, from housing, services to public administration, culture and cults can be registered, completed in the last 2 years, in the rural environment.



07.

The architecture of public space

It is desired to bring value to urban design interventions, permanent arrangements of public spaces and landscaping interventions of any size. The section includes all projects in public space areas, from the development of squares, alleys, waterfronts, tourist routes, to gardens and parks, leisure areas, green areas, play areas, developed in the last 2 years, completed or in progress.

Participating projects must be carried out by architects who are members of the partner OAR Branches: OAR Transilvania, OAR Bihor, OAR Satu-Mare, OAR Nord-Vest, OAR Alba, including those from Diaspora. Architects who are members of any OAR Territorial Branch can also participate, provided that the work entered in the competition is located in one of the following counties: Cluj, Bistriţa-Năsăud, Sălaj, Alba, Bihor, Maramures and Satu-Mare.

08.

The architecture of the interior space

This section wishes to promote both the ambience of public interior space (commerce, culture, offices, education, health, leisure sports, services or administration) and of private interior space (residential). Interior design projects completed in the last 2 years, regardless of the building function or the scale of the project, can participate in this section.



9.

Microarchitecture / Temporary architecture / Scenography

Through this section, small interventions (under 100 square meters) will be highlighted, with a significant impact on the environment in which they intervene. We encourage the most varied initiatives starting from temporary arrangements of public and private spaces, to pavilions, stands at events and festivals, as well as interventions dedicated to the show, completed in the last 2 years.

Participating projects must be carried out by architects who are members of the partner OAR Branches: OAR Transilvania, OAR Bihor, OAR Satu-Mare, OAR Nord-Vest, OAR Alba, including those from Diaspora. Architects who are members of any OAR Territorial Branch can also participate, provided that the work entered in the competition is located in one of the following counties: Cluj, Bistriţa-Năsăud, Sălaj, Alba, Bihor, Maramureş and Satu-Mare.

10.

Object design

Within the section there are object design projects, from furniture, lighting fixtures, decorative objects.

Participating projects must be carried out by architects who are members of the partner OAR Branches: OAR Transilvania, OAR Bihor, OAR Satu-Mare, OAR Nord-Vest, OAR Alba, including those from Diaspora. Architects who are members of any OAR Territorial Branch can also participate, provided that the work entered in the competition is located in one of the following counties: Cluj, Bistriţa-Năsăud, Sălaj, Alba, Bihor, Maramureş and Satu-Mare.

11.

Cultural projects / Initiatives / Experiments

This section aims to provide a platform for projects, initiatives and cultural experiments that build bridges between fields and people. This section is open to both built architecture, written architecture, and lived architecture through interventions that unite people, spaces and communities. Participating projects must have been completed within the last 2 years.



Special sections

12.

Architecture photography

We invite professional or amateur architects and photographers to apply with architectural photos.

Architectural photos mean those photos that reproduce architecture put into operation, dedicated to the general public, that promote quality in architecture, architects, administrations or communities that have succeeded in redefining urban or rural, public or private spaces.

The section has no participation restrictions.

13.

"Poetry with/about Architecture"

Architecture is everywhere, even in the most unexpected places. Lyrics can capture the essence of spaces through words, often better than any other form of written art. We invite you to this section, to register poems with and about spaces, architecture and the relationship between man and the experience of exploring this environment.

The section has no participation restrictions.

14.

"impACT collaborations"

This section is dedicated to that story where the relationship between architect - client, architect - engineers, architect - builder, architect - craftsman, architect - artist, architect - dealer / supplier of materials is an enviable one in the industry and is the relationship that everyone should aspire to.

The proposal will be made on the recommendation of an architect whose work is registered with BATRA 2023.

15.

Civic initiatives

This section is dedicated to those who have presented in a sustained and constructive way real community needs related to public space, new architectural programs, inclusive spaces, etc.

The section has no participation restrictions and is not limited to the territory of BATRA, being open to projects carried out throughout the country.



Chapter V. General conditions of participation

1.

All members of the partner OAR Branches: OAR Transilvania, OAR Bihor, OAR Satu-Mare, OAR Nord-Vest, OAR Alba are invited to participate in sections 1-11 of this exhibition, including those from the Diaspora, in one or more sections, with one or more representative works, from the country and abroad. Participation assumes the capacity of author, co-author with equal rights of the architectural project or architect from the design team, who assumes the consent of the main author by entering the competition. Also, member architects and collectives coordinated by member architects of any OAR Territorial Branch may participate, provided that the work entered in the competition is located in the BATRA territory, i.e. in one of the following counties: Cluj, Bistriţa-Năsăud, Sălaj, Alba, Bihor, Maramureş and Satu-Mare.

2.

In section 10, collaborators of member architects of partner OAR Branches, designers and manufacturers are admitted. In this case, the completed object must be accompanied by the recommendation of an architect from the partner branches who used it in his works or appreciated it.

- 3. In sections 12, 13, 15, participation is not restricted.
- 4.

In section 14, the proposal will be made based on the recommendation of an architect whose work is registered with BATRA 2023

7.

The participants in sections 1-11 must have their dues paid up to date, for the year 2023, or prove their "up-to-date" membership of the professional organizations in their country of residence.

8.

Each author or group of authors can submit papers to one or more sections in the same edition. The number of works presented by an author or a collective in each section is unlimited.

9.

The same work cannot be presented in several sections, unless the different fields of intervention can be clearly delineated (urban operation and architectural object, architectural object and object design).

10.

Architecture and interior design within the same object cannot be presented separately, unless the authors are different



Chapter V. General conditions of participation

11.

It is not allowed to participate with works presented in previous editions, in the same section, except in the case of later phases with an essential weight within larger projects.

12.

The term "completed work" means a work completed at least 90% (architectural work, interior design, urban space planning, restoration and rehabilitation), completed research, products or prototypes carried out (for the "object design" category ").

13.

The term "completed in the last two years" means the period between September 2021 and September 2023.

14.

Enrolment of participants in the exhibition-competition and submission of projects is done under the terms of these Regulations and expresses implicit agreement with all of its provisions

15.

In addition, architects who want to participate in the Transylvania Architecture Biennale, but need volunteers to make the panels, are asked to send an email with this request to contact@batra.ro We want to generate a bridge between architectural students and professionals in the hope of defining some natural developments.

16.

The panels of works participating in the competition will be listed by a specialized company. The organizers assume no responsibility for the quality of the prints.

Chapter VIII. Evaluation criteria

The BATRA 2023 awards aim to promote the most valuable works from a wide range of functions and interests related to architectural practice. The selection criteria for nominations and awards do not only refer to the correctness and aesthetic value of some solutions, but will consider the following aspects as a matter of priority:

- Respect for the context (urban and/or cultural) or a constructive dialogue with it and how the interventions integrate and increase the value of the space or community. In this sense, images, street developments and / or relevant situation plans will be transmitted. In addition, the text will detail these aspects.
- Spatial and constructive innovation, the degree of creativity and originality of the design, as well as the aesthetic quality of the object or space. Compositional coherence down to the detail.
- Degree of sustainability. The New European Bauhaus promotes a sustainable approach to design and architecture. Approaches thought out and implemented in harmony with nature, solutions that are designed to reduce environmental impact will be appreciated.

- Accessibility and inclusiveness for all users.
 Solutions that reflect and support cultural and social diversity in design.
- Integrated approach to design and architecture in a sustainable, accessible and aesthetic way.
- Mention of the framing elements in the (imp)ACT topic, where appropriate.

Awards

- For each section, the jury will select three nominations from which the section award will be selected.
- The jury will appoint a presiding judge by vote and establish its own working procedure.
- If at least three works are not entered in one of the sections, the jury reserves the right to nominate and award a prize for that category depending on the quality of the project / projects entered.

Special situations

- 1. The organizing team reserves the right not to exhibit / enter in the competition the works that violate elementary principles of composition, professional ethics or legislation in the construction field.
- 2. The composition of the jury is as defined above, but the organizing team reserves the right to make changes in the composition of the jury in special cases that prevent the participation of one or several members.
